**OD6 Metals Limited (ASX:OD6) – Request for trading halt**

Pursuant to ASX Listing Rule 17.1, OD6 Metals Limited (**Company**) requests an immediate trading halt be granted by ASX in respect of its ordinary shares, effective today, 2 March 2026.

In accordance with ASX Listing Rule 17.1, the Company provides the following information:

1. **Reason for trading halt** – The trading halt is requested pending an announcement of a material acquisition of a US Critical Minerals project and a capital raising (**Announcement**).
2. **Duration of the trading halt** – the Company anticipates that the trading halt will remain in place until the earlier of such time as it makes the Announcement and the commencement of trading on Wednesday, 4 March 2026.
3. **Termination of the trading halt** – the Company anticipates that the trading halt will cease upon it making the Announcement.
4. **No reason** – the Company is not aware of any reason why the trading halt should not be granted.
5. **Further information** – the Company is not aware of any other information to inform the market about the trading halt.
